Erasmus+ KA103: Trainee Mobility within E+ programme countries

The SENDING organisation should be Higher Education Institution HEI, with Erasmus+ PIC (Participant Identification Code) Erasmus+ ECHE (Erasmus Charter) EXTENDED to Traineeships

The RECEIVING organisation could be: • An HEI in a EU country

OR

· Any Other Relevant Workplace (AORW) in EU, including enterprises, NGO, Research Institutes

PRINCIPLE:

Students Staff



- No need for interinstitutional agreements (placement contract is sufficient)
 - No deadline for procedures
 - The traineeship allows collaborations between institutions
- · For the students: the training period is recognized in the study programme (validation of ECTS grades)
- For staff: continued learning networking with colleagues in EU

ADDITIONAL BENEFIT FOR STAFF: the opportunity to participate to a week of "Staff Mobility for Training" (STT, <u>not a conference</u>), on a biosafety topic


- Organized by an HEI (with PIC and ECHE)
- · For teaching and Non-teaching staff (usually limited to 20 persons)
- People from AORW could be invited

Erasmus+ KA107: International Credit Mobility (ICM)

Any HEI (with PIC and ECHE) of a Erasmus programme country (PROGR HEI) could establish a partnership with (at least) one HEI in a partner Country (PARTN HEI) with the aim to exchange students/staff for studies and traineeship (including biosafety traineeships)

- PARTN HEI are classified in 14 REGIONS
- Erasmus+ policy promotes exchanges with 4 REGIONS (* on the map)

PRINCIPLE:



APPLICATION / SELECTION PROCEDURE:

- Application by the PROGR HEI, in collaboration with PARTN HEI
- Selection : quality assessment of Relevance, Quality of Cooperation, Project design, ...
- Deadline: 1st of February
- Grant awarded for two years (one grant/PARTN Country; several grants/PROGR HEI)

BENEFITS

= those of KA103 plus:

The opportunity to extend the biosafety network at the International level

Erasmus+ KA2 Cooperation for innovation and Exchanges of good practices: Capacity Building in Higher Education

PRINCIPLE:



HEI in 3 ≠ PROGR countries HEI in 3 ≠ PARTN countries

APPLICATION / SELECTION PROCEDURE:

- Application by the 3 PROGR HEI, in collaboration with 3 PARTN HEI of a same region
- Selection : quality assessment of Relevance, Quality of Cooperation, Project design, ...
- Deadline: second Thursday of February
- Grant awarded for three years (one grant/PARTN Country; several grants/PROGR HEI)

BENEFITS

= those of KA103 and KAI07 plus:

Long-lasting positive impacts on HEIs and the civil society in PARTN countries
